

**North Grove Public Improvement District
Improvement Area #3
Project – Lot Size – 70 Ft.**

Project Overview

The North Grove Public Improvement District (the “District”) was created by the City of Waxahachie City Council on September 15, 2014, pursuant to the Public Improvement District Assessment Act, Texas Local Government Code, Chapter 372, as amended (the “Act”), and Resolution No. 1189 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvements (the “Authorized Improvements”) that specially benefit assessed property in the District. All of the property in the District is located within the corporate limits of the City of Waxahachie (the “City”). On May 16, 2022, the City Council adopted Ordinance No. 3326 that approved an updated Service and Assessment Plan for Improvement Area #3 of the District (the "Updated Service and Assessment Plan") and levied special assessments for Improvement Area #3 (the "Improvement Area #3 Assessments") on certain property within Improvement Area #3 of the District in accordance with the Assessment Roll attached as Appendix F-3 to the Updated Service and Assessment Plan. The Assessments may be prepaid in whole or in part at any time or may be paid in annual installments as provided by the Act and the Service and Assessment Plan.

The City issued the City of Waxahachie (North Grove Public Improvement District Neighborhood Improvement Areas #2-3 Project) Special Assessment Revenue Bonds, Series 2022 (the “IA #2-3 Bonds”) in the aggregate amount of \$5,825,000 pursuant to the Act, an Ordinance adopted by the City Council on May 16, 2022 and an Indenture of Trust dated as of June 1, 2022 between the City, and the Wilmington Trust N.A. as trustee. Parcels within Improvement Area #2 (the “IA #2”) of the District were levied \$1,870,000 for costs of the IA #2 Authorized Improvements; while Parcels within Improvement Area #3 (the “IA #3”) of the District were levied \$3,955,000 for costs of the IA #3 Authorized Improvements.

All Assessments that are not paid in full will be billed in annual installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. **Annual Installments are billed by the Ellis County Tax Office and are due and payable as provided on the annual installment assessment bill.** Annual installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

The exact amount of each annual installment will be approved each year by the City Council in the Annual Service Plan Update for the District. - 1 - The Annual Installment billed during Year 2025 will be billed by the Ellis County Tax Office on or around 10/01/25 and payment is due by 01/31/26.
- 2 - The principal and interest amounts are based upon the pro rata share of IA #2-3 Bonds and will not increase during the life of the Bonds. Interest amounts are calculated through the principal payment date of each year and include additional interest of one-half of one percent for debt service reserves.
- 3 - The Administrative Expenses will be updated each year in the Annual Service Plan update.

THIS SCHEDULE IS AN ESTIMATE OF ANNUAL INSTALLMENT PAYMENTS AND IS SUBJECT TO CHANGE. THE EXACT AMOUNT OF EACH ANNUAL INSTALLMENT WILL BE REFLECTED IN THE NORTH GROVE PUBLIC IMPROVEMENT DISTRICT ANNUAL SERVICE AND ASSESSMENT PLAN UPDATE.

Property Owners may choose to prepay their Assessment at any time. Effective January 1, 2024, for any single-family residential parcel prepaying an Assessment, a \$500 fee will be included in the total payoff amount to cover processing and other lien release related filing expenses.
